Federal Assistance Form SF-424

- Basic information about organization and project
- Block #19: Executive Order 12372 on intergovernmental review
 - No; only applicable to California and Utah

Form 4700-4 - Nondiscrimination

- Recent requirement, effective January 2023
- Attestation of compliance will Title VI of Civil Rights Act
 - Race, color, national origin or sex
 - Handicap
 - 40 C.F.R. 7.70 Accessibility in new construction Exempt: "(...) mechanical rooms and other spaces that, because of their intended use, will not require accessibility to the public or beneficiaries or result in the employment or residence therein of persons with physical handicaps."



Form 4700-4 - Nondiscrimination

- Notice of Nondiscrimination
- Must accommodate vision or hearing impaired
- Must be posted in a physical location (see 40 C.F.R. 7.95)
- Where "appropriate", provide in other languages
- Grievance procedure
- See <u>EPA's resources</u> on Civil Rights, including a <u>checklist</u>
- Example from <u>Sandy Springs</u>, <u>GA</u> (but DOT tailored)



Lobbying Forms

- Do not use grant funds for lobbying activities!
- **EPA Form 6600-06**: Certification Regarding Lobbying
 - Required for all awards >\$100K
- Form SF-LLL: Disclosure of Lobbying Activities



2. Tips for Success

Tips From Local Governments

- Know what your local government already has in place and what it doesn't
 - Need a UEI? (Sam.gov)
 - Grants.gov login/access?
 - Grievance procedures?
 - Nondiscrimination Coordinator? (40 C.F.R. parts 5 & 7)
- How to find out?
 - o Talk to your Clerk of Council, Legal Counsel, Finance, Budget, etc.
 - Any department/division that may have worked with federal funds
